Use one part HDIC and eight parts water.

Walls, Gymnasiums, Presses, Wooden Mats, Greasy Floors, White Wall Tiles, Swimming Pools:

Use one part HDIC and ten parts water.

Lockers, Steel Files, Cabinets, Light Cleaning Jobs, Decorative Surfaces, Floors (Tile, Ceramic, Vinyl, Terrazzo, Rubber, Concrete:

Use one part HDIC and twenty part water.

REMOVAL OF WAX:

Terrazzo, Rubber Vinyl, Asphalt Tile, and other types of floors:

Use one part HDIC and eight parts water.
